1. This Agreement takes effect on the day the user's keys are mailed out and documented by SFRTA personnel. This Agreement grants the user a conditional license to store a standard-sized, two-wheel bicycle and accompanying equipment (helmet, air pump, bike lock, water container) in an assigned locker for the term of the Agreement. THE STORAGE OF MOTOR FUEL IS PROHIBITED. THE STORAGE OF PERSONAL ITEMS, INCLUDING BACKPACKS, TOOLBOXES AND OTHER ITEMS UNRELATED TO BICYCLE USE IS ALSO PROHIBITED. The user agrees that items may be stored in the locker at user's own risk. SFRTA cannot guarantee the security of items stored in a locker and SFRTA is not responsible for theft or damage to any stored items. The SFRTA may inspect the contents of the locker at any time, without prior notice to the user and without the user present, and remove any items other than those allowed under this Agreement. Users are required to provide the SFRTA with identifying information (Name, Physical Address and Date of Birth) as requested on the Application and Agreement and must be 18 years or older to sign this Agreement.
2. To renew this Agreement, the user must notify the SFRTA in writing at least two (2) weeks prior to the expiration date of the user's intention to do so or the SFRTA cannot guarantee that a locker will be available after the expiration date. The user will be required to renew their existing Agreement or execute a new Agreement before the expiration date of the current Agreement. The SFRTA, at its sole discretion, may not agree to renew the Agreement.
3. Users shall comply with all SFRTA Bike Regulations (a full listing of SFRTA Bike regulations can be found online at [www.tri-rail.com](http://www.tri-rail.com)).
4. The user is responsible for insuring that the locker is secure at all times and for reporting any damage to user's locker or any adjacent lockers to the SFRTA. Users may not substitute their own locks and keys or make any changes to the locker's physical appearance. Only SFRTA- provided locks may be used to secure lockers. If the locker or lock becomes unusable due to no fault of user, the user will be assigned another locker, if one is available. If a locker key is lost, the user will be charged for a lock change and a replacement key. If a user requests assistance in accessing his or her locker due to a lost key, the user must provide the SFRTA with at least forty-eight (48) hours advance notice. Any duplication of SFRTA issued keys is strictly prohibited.
5. The user may terminate this Agreement at any time by providing the SFRTA with at least forty-eight (48) hours notice. The user's \$20 deposit will be refunded. The SFRTA may terminate this Agreement for convenience with forty-eight (48) hours notice to the user; however, the SFRTA may cancel this Agreement immediately for any unauthorized use of the locker or in the event the SFRTA determines, in its sole discretion, that it is necessary for security or safety reasons or because the user has breached the terms of this Agreement including providing a Non-Sufficient Funds Check as payment. If SFRTA terminates the Agreement for user's unauthorized use or breach of the Agreement, user shall not be entitled to a refund of the locker deposit.
6. The user agrees to indemnify and hold harmless the SFRTA the Florida Department of Transportation, and CSXT Transportation, Inc., its officers, employees and agents from any liability of any nature arising from use of the locker, including theft of any items stored in the locker.
7. Personal information provided by the user to the SFRTA is public information and subject to disclosure under Chapter 119, Florida Statutes.
8. Upon termination other than for user's unauthorized use or breach of the agreement, the user shall remove any property from the locker and return the key to the SFRTA within forty-eight (48) hours. Upon receipt of the key and an inspection to determine that the locker is clean and free of damage, the user's locker deposit will be returned by check within thirty (30) days, mailed to the user's address provided in the Agreement. Failure to return the key or to remove any items from the locker will result in a forfeiture of the user's locker deposit. Any unreported damage to the locker will result in forfeiture of the locker deposit. Any property left in the locker after the termination date will be retained by the SFRTA as abandoned property.
9. This Agreement constitutes the entire Agreement between the parties. This Agreement shall not be amended unless it is by written agreement executed by both parties. This Agreement may not be assigned by user, nor shall user permit another person to store a bicycle or any other article in user's locker.
